##### Appropriate engineering controls

Provide adequate general and local exhaust ventilation. Use approved respirator if air contamination is above an acceptable level. Ensure operatives are trained to minimize exposure. Personal protective equipment should only be used if worker exposure cannot be controlled adequately by the engineering control measures.

##### Eye/face protection

Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible. The following protection should be worn: Chemical splash goggles. Personal protective equipment for eye and face protection should comply with OSHA 1910.133.

##### Hand protection

Wear protective gloves made of the following material: Rubber or plastic. To protect hands from chemicals, gloves should comply with OSHA 1910.138 and be demonstrated to be impervious to the chemical and resist degradation. The breakthrough time for any glove material may be different for different glove manufacturers. When used with mixtures, the protection time of gloves cannot be accurately estimated. It is recommended that gloves are made of the following material: Butyl rubber. Laminate of polyethylene and ethylene vinyl alcohol (PE/EVOH). Neoprene. Frequent changes are recommended. The selected gloves should have a breakthrough time of at least 6 hours.

##### Other skin and body protection

Wear apron or protective clothing in case of contact.

##### Hygiene measures

Provide eyewash station and safety shower. Keep away from food, drink and animal feeding stuffs. Good personal hygiene procedures should be implemented. Wash hands and any other contaminated areas of the body with soap and water before leaving the work site. Do not eat, drink or smoke when using the product. Change work clothing daily before leaving workplace.

##### Respiratory protection

If ventilation is inadequate, suitable respiratory protection must be worn. Wear a respirator fitted with the following cartridge: Combination filter, type A2/P2. Ensure all respiratory protective equipment is suitable for its intended use and is NIOSH approved.
