# 4. First-aid measures

Inhalation

## 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. # Methods and materials for containment and cleaning up

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. #### 7. Handling and storage

#### Precautions for safe handling

# Conditions for safe storage, including any incompatibilities
