**4. First-aid measures**

**Methods and materials for containment and cleaning up**

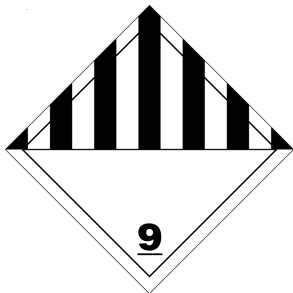

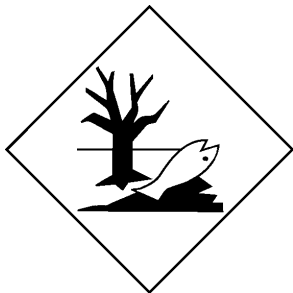
