### 4. First-aid measures

**Methods and materials for containment and cleaning up**

Prevent entry into waterways, sewer, basements or confined areas.

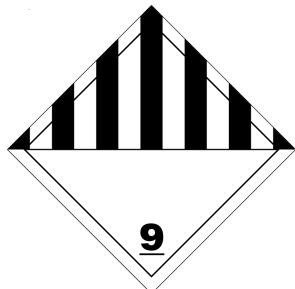

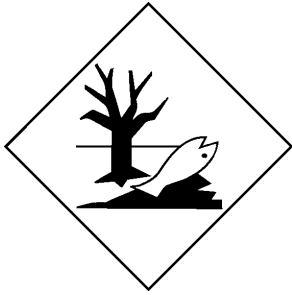
